# MEMBERSHIP OF EMMANUEL INTERNATIONAL UK

EIUK welcomes into membership Christians who are in sympathy with its aims and objectives and who would like the opportunity of deeper involvement with the organisation by having the power to vote on key issues in the life and development of the EIUK mission to the world.

## Our objectives are:

- To propagate the Gospel of Jesus Christ in the United Kingdom and abroad by establishing churches and assisting indigenous Christian Organisations.
- To relieve poverty and sickness and to advance education throughout the world.

## Membership is open to adults who register their interest by completing the form opposite, subject to the following conditions:

- Payment of an annual subscription of £30 separate from any donation for the work of EIUK. Joint membership to include a spouse is £39 per annum.
- Agreement with the Memorandum and Articles of Association of EIUK including the Basis of Faith. Copies of these are available on request from the EIUK office.
- Election to Membership by the EIUK Board.

Once admitted, you don't have to reapply to the Board on an annual basis. Your membership continues upon payment of the annual subscription. You do need, however, to complete the membership form to accompany the fee.

The Overseas Workers, Board Members, Link Secretaries and Staff are considered as members without subscription during their service. However, they must sign the appropriate form to register their agreement with the above conditions before their membership is accepted.
